Personal Financial Literacy

COURSES WILL BE OFFERED ONLY IF THERE IS SUFFICIENT ENROLLMENT

In the Northern Valley High School District, courses taken for new credit will not be computed in class rank nor count toward grade point averages.

- Proof of residence will be requested at registration.

***Students are required to attend all three mandatory in-person sessions.**

PFL Summer School Guidelines

Attendance

Students are required to complete 60 hours of instruction. This requirement is necessary in order to uphold accreditation standards. Students are required to attend all 3 in-person meetings. The policy will be enforced regardless of the reason for being absent. Students arriving fifteen minutes late or more are absent for the day. If a student is given an Administrative Withdrawal, tuition will not be refunded.

Examinations and Report Cards

Report cards for credit courses will be issued every ten days. Final examination for credit courses will be administered the last day of summer school. Students are asked to bring in a stamped envelope for each course they are taking if they wish to have the report card mailed home upon the completion of summer school.

Amount of Work

For credit courses, the amount of work to be completed is the same as required during the regular school year.

Student Drop-Off and Pick Up

Students may be dropped off in front of the school prior to the beginning of class. Cars should pull up as far as possible to allow for others to clear the driveway.

Students taking personal financial literacy will be dismissed at 10:45 am on the three days of mandatory attendance.

School Code of Conduct

A. Tardiness as a result of bus schedules, trains, flat tires, etc., will not be excused.

B. Books and supplies must be handled carefully.

C. Students must abide by the same rules of conduct that apply within Northern Valley High Schools at other times during the year.

D. Attire may be informal and comfortable, but should be in keeping with prevailing school standards.

E. No smoking is permitted on school grounds or anywhere in any part of the school building.

F. Cars are permitted when driven carefully and should be parked only in the student lot, north of the building.

G. Students who do not abide by the rules will be dropped without a refund of tuition.
